It was an enjoyable experience being part of the kickoff EVAC meeting and learning more about our charter and a little bit about each of you. I'm excited about our group and what lies ahead. In that spirit, I'd like to put my name forward to be the co-chair of EVAC.

My vision is for us to think big and push Minneapolis to be the most energy efficient city in the nation – and then the world. I'd like to tap our collective backgrounds, talents, and insights to flesh out ideas and coalesce around core programs that business people, political leaders, utility partners, and our citizens can get excited about and rally behind.

I work for the Minneapolis Public Housing Authority, an agency that provides safe and affordable housing to 5% of the city's population in properties totaling 3.25 million square feet. Part of my job is overseeing a \$33 million dollar Energy Performance Contract dedicated to high-rise buildings. Through this contract, MPHA has replaced antiquated, inefficient boilers, heaters, plumbing, and light fixtures with new and innovative gas, water, and electrical savings equipment and monitoring software. The result has been over 10% annual reductions in our energy usage, less CO2, and a win-win for the city and the public at large.

I'm proud of what MPHA has accomplished. I'll bring managerial skills and an ability to work with diverse stakeholders to the co-chair position. I'm a good listener and a consensus builder who can see the big picture while keeping mindful of details. I'm fun to work with and passionate about conservation, and I look forward to helping Minneapolis plan for a long term, energy efficient future.

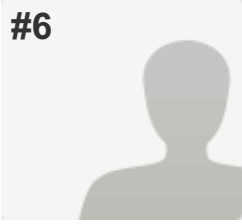
