

2022-2023 Work Plan Updates







Theme 1: DECARBONIZE HOMES VIA ELECTRIFICATION & ENERGY EFFICIENCY RETROFITS

Activities Update:

1. Home Electrification Guide

- Draft website built
- Framing as a beneficial resource for all homes in our region, not just Mpls
- Review content over next month
- Launch around the New Year

2. Comprehensive Roadmap for Home Electrification and Energy Efficiency

- Work group has met 2 times, one time remaining before this deliverable
- Developed common understanding of:
 - State of Mpls housing stock
 - Benefits of electrification
 - Importance of weatherization
 - Challenges of current technology and to utility systems
- Meet next to geographic impacts, demographic impacts, sequencing/rollout, and funding stacking







Theme 2: EQUITABLY ACCELERATE IN-BOUNDARY SOLAR IN SUPPORT OF THE CITY'S 2030 GOAL OF 30% DISTRIBUTED SOLAR

Activities Updates:

- **A.** Municipal Operations Renewable Electricity: Some ideas discussed in the task force, more specific conversations on this topic in early 2023.
- **B.** Resilient Minneapolis Project: The RFP to engineer, procure and construct three Resilient Minneapolis Project microgrids was issued in late November. Following an earlier RFI to narrow the bidders list, the RFP was sent to seven potential bidders with experience constructing battery storage and/or microgrid projects worldwide. The RFP will be open through January 6.
- **C. In-boundary Solar Work Group**: Two meetings have been held. Discussion has focused on sharing data on interconnection timelines and discussing programmatic concepts.







Theme 3: IMPACTFUL REDUCTIONS IN COMMERCIAL AND INDUSTRIAL BUILDING GAS USE



Activities Updates:

- **A.** Leverage Existing Partnership Resources: CenterPoint and the City commit to increase participation and energy savings through CIP and decrease GHG emissions from C/I buildings within the City.
 - -- New Normal Campaign development
 - -- Update on work with large Minneapolis C&I customer
- **A.** New Electrification and Decarbonization Opportunities: CenterPoint will partner with Hennepin County to develop, evaluate, and consider opportunities to decarbonize their downtown district energy center (adjacent to US Bank Stadium).
 - -- Funding has been committed for project
 - -- Hennepin County, the City, and CenterPoint meeting monthly
 - -- Final report expected Q2 2023
